County to pay \$3.2M settlement

■ Deputy involved in collision that left 1 with brain injury

Ventura County has agreed to a \$3.2 million settlement in a civil case after an investigation found that a sheriff's deputy was speeding when his patrol car rammed a truck driven by a Santa Paula woman who suffered a traumatic brain injury.

The California Highway Patrol initially blamed the woman, Mayra Tellez, 25, for the crash but later found she wasn't the primary cause.

Tellez was driving a pickup on April 17, 2010, when it was struck by the deputy's vehicle on Highway 126, west of Timber Canyon Road near Santa Paula.

After the accident, CHP officials said the pickup had made a sudden left turn in front of the patrol car. The county's attorney Jim Procter, said CHP performed a subsequent investigation.

"Initially, what they found was the primary collision factor was Ms. Tellez had violated the deputy's right of way," Procter said. "It turned out that the deputy was exceeding the speed limit, and it's a difficult curve out there on 126. Her sight distance was obstructed by a curve in the road and an orchard adjacent to the driveway. So, ultimately, we felt it was a case of some liability and a case that ought to be settled, particularly given the fact that she had such serious injuries."

Deputy William Meixner was driving the police cruiser. Deputy Beau Rodriguez was a passenger. They had just completed a traffic stop and were eastbound on Highway 126 when the collision occurred.

In a recorded statement made at the hospital, Meixner said he was traveling 55 to 60 miles per hour, said Tellez's lawyer, Bradford Brown. However, Brown subpoenaed information from a crash data recorder attached to the police cruiser that he said showed otherwise.

"The cruiser's computer pegged them at 96 miles per hour one second before impact," he said.

Procter said the county's accident reconstruction expert didn't think it was that fast.
